### HIGHLIGHTS:

**Daily Reports from the TennCare Sit-in** – Every day of the two-and-a-half month Nashville TennCare sit-in I produced an update, most original pieces from primary sources, to encourage and expand the grassroots advocacy efforts of the Tennessee coalition organizing the sit-in [<http://www.mcil.org/mcil/log/2005/tenncare.asp>].



**Free Our People March Coordinator** – From January to September 2003 I was one of 19 volunteer National Coordinators for the Free Our People March. My specific duties were to raise money for the march, develop the [<http://www.FreeOurPeople.org>] website and produce Internet related media everyday of the march (Photo by Tom Olin).

**ADAPT Action Report** – Since 1999 I have produced and edited the ADAPT Action Report for every national action and many local and regional actions [<http://www.adapt.org/freeourpeople/aar/>].



**Rental Housing Accessibility Survey** – On January 29, 2001 I published a Survey and Additional Detail describing over 1,700 barriers to people with disabilities [<http://www.mcil.org/mcil/news/mcil371s.pdf>]. The resulting lawsuit *MCIL v. Makowski* [Tennessee Western District 01-2069], was joined by the US Department of Justice in October [<http://www.usdoj.gov/opa/pr/2001/October/518cr.htm>].

**CPWD Consumer Survey** – I organized people with disabilities to produce two transportation accessibility surveys. In April of 2004 [<http://www.cpwd-ilc.org/cpwd/ilp/survey04/>] and June of 2005 [<http://www.cpwd-ilc.org/cpwd/ilp/survey05/>] CPWD consumers published findings of accessibility surveys that improved access to transportation in the Boulder area.
